1991 - 2003	Acquisition of some banks (Istituto Bancario Siciliano and Banca di Girgenti in 1991, Banca Creditwest e dei comuni vesuviani in 1995 and Banca della provincia di Napoli in 1998)
1993	Origin of Gruppo Bancario Credito Emiliano – Credem headed by Credito Emiliano Holding
1994	Acquisition of Euromobiliare Group
1997	Listed on Italian stock exchange
2003	The internal expansion plan continues, mainly in north-west and Adriatic area
2008	Acquisition of some branches from Citybank, Unicredit and Banco Popolare

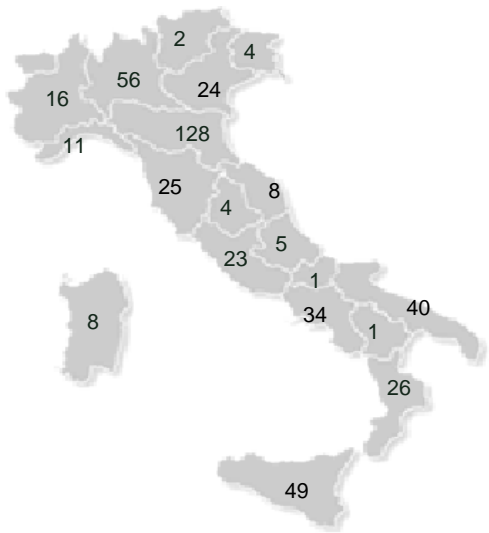
